

## **2010 TGS VENDOR GUIDELINES**

Festival Hours: Fri, 15<sup>th</sup>, 9 am to 5 pm. Sat, 16<sup>th</sup>, 9 am to 5 pm. Sun 17<sup>th</sup> 10 am to 4 pm.

**Vendor Setup:** Thursday 14<sup>th</sup> at 1 pm till 7 pm.

**Unloading/Loading:** There will be 10 foot over-head doors for vendor use.

**Breakdown** Sunday the 17<sup>th</sup>, 4 pm. till 6 pm. **NO EARLY BREAKDOWNS.**

**Each vendor will be allowed a total of three name tags per vendor booth rented. One for the vendor and two for additional helpers/workers. NO EXCEPTION.**

**Additional name tags may be purchased @ \$5.00 each.**

**CLEAN GOURDS MUST PREDOMINATE!** Vendors will be allowed to sell only **CLEAN DRY GOURDS, GREEN GOURDS, GOURD ART/CRAFT & GOURD RELATED PRODUCTS** such as gourd tools, dyes, beads & paints **THAT ARE USED IN THE EMBELISHMENT OF GOURDS. NO COSMETICS, LOTIONS OR CREAMS OF ANY KIND. ALL GOURDS MUST BE CLEAN AND FREE OF DIRT.**

Vendors must have their registration forms and **FEES TO THE VENDOR CHAIR** by 1 JULY 2010 as determined by postmark, or personal contact. Vendor space requested after the deadline will be awarded on availability. Make checks payable to **TEXAS GOURD SOCIETY, INC.** All proceeds support the TGS, a not for profit organization.

**ONCE ACCEPTED AS A VENDOR BY TGS, THERE ARE NO REFUNDS.**

Each vendor must furnish his/her own table covering and other accessories. All tables must be covered and draped to the floor. Tables, chairs, and electricity are available for a fee, see booth and equipment cost schedule. **NOTE:** The fairground exhibition hall does not have central air or heat; you are advised to dress appropriately. A fan may help with the heat, this is your call. **Neither Texas Gourd Society nor Gillespie County Fairgrounds provide electrical extension cords. This is a vendor responsibility.** **NOTE:** Only service animals to aid the handicap will be allowed. **NO PETS.**

**All SALES TAX IS THE INDIVIDUAL VENDORS RESPONSIBILITY.** For help with Texas Sales Tax information go to [www.window.state.tx.us](http://www.window.state.tx.us) or call, 1 800 252 5555.

**Vendor's will be responsible to contain all display, sales and viewing area within the rented space to alleviate encroachment on adjoining spaces or walkways. Vendor's booths must remain open during festival hours of operation.**

**Vendor's membership dues must be current when submitting vendor contract and during 2010 festival to qualify for TGS member rate.**
